Preparing evidence for an employment tribunal in England ...

ET1 Form. To start a claim, the claimant must fill in an ET1 form to describe their claim. This is the first document the tribunal will read so it is important to set out the claim clearly. The ET1 form must be received by the tribunal, not just posted, by the deadline for making a claim.

Preparing an employment tribunal case. Information about how to prepare for an employment tribunal, including gathering documents, finding witnesses, and making sure you are familiar with any instructions (orders or directions) sent to you by the tribunal.

Employment tribunals - Citizens Advice

The Tribunal will order you and the Respondent to disclose documents to each other by a certain date, so that a bundle of documents can be compiled for use at the hearing. When disclosing documents, you are expected to provide a detailed list, giving the name and date of the document, and/or to provide copies of the documents concerned.

Form ET1: Single claimant making a claim to an employment tribunal. Form ET1A: Multiple claimants can use this form to make claims against you. Form ET3: You should use this form to respond to a claim made by an employee to the employment tribunal. Form T439: A signed declaration from self-employed witnesses claiming loss of earnings.

Requesting an order from the Employment Tribunal for additional information and documents. If the Respondent will not supply the Claimant with answers and documents in good time, write a letter to the tribunal with a copy of the original request and ask for an Order. The letter to the tribunal must briefly state why the requested information and documents are relevant to the case.
