The ECS Health, Safety & Environmental assessment is specifically designed to meet the basic Health & Safety requirements of electrotechnical personnel. Those who successfully pass the ECS assessment will be awarded with an ECS H&S Certificate, issued by the JIB or SJIB, which can be used to obtain an ECS card within two years of passing the assessment.

The ECS H&S Assessment pass is valid for 2 years. You must submit your ECS application within that two-year period, or you ' ll need to do a new assessment before your application can be processed.
