Reference examples. Include the full title of the journal in your reference. Abbreviated titles are not used in the Leeds Harvard style. Use p. to reference a single page, and pp. for a range of pages. If you are referencing a journal article which you have read online (on a website or as a PDF), you do not need to include [online], the URL or the access date in your reference.

Journal article | Leeds Harvard referencing examples ...

Title of article (in single quotation marks). Title of journal (in italics – capitalise first letter of each word in title, except for linking words such as and, of, the, for). Issue information, that is, volume (unbracketed) and, where applicable, part number, month or season (all in round brackets).

In-Text Citations for a Journal Article in Harvard Referencing. To cite a journal article, you need to provide the author's surname and the year of publication (separated by a comma) in parentheses: The yellow plumage indicates a blue tit's diet (Couzens, 2010). If you name the author(s) in the text, only the year of publication is required:

Even if an article is accessed through a library database, e.g. ProQuest or Expanded Academic, reference it the same as the print and pdf article examples. Do not include the name of the database or a URL. Refer to the examples for Article from a journal print or pdf.

The essential elements you require to create a journal article reference include: Author or authors including surname and initial. [Call out: include the second initial if available]; Year of publication, Title of article.

How to Cite an Online Journal or Newspaper Article in Harvard Format. To cite an online journal or newspaper article, the page numbers section from the print journal or newspaper reference is swapped with the URL or DOI the article can be accessed from and when it was accessed. So the reference for an online journal article is: Author surname(s), initial(s). (Year) 'Title of article', Title of journal, volume(issue/season) [online]. Available at: URL or DOI (Accessed: day month year)

Page reference. doi (if available). In an effort to simplify journal referencing, as long as the journal reference provides enough bibliographic information for the article to be located, other elements no longer need to be included, for example [Online], database title and URL. In-text citation:

Note: Journal articles taken from the Internet or a database should be cited as print using the rules above. However if the article is only available online (for example there are no page numbers) reference as below. AUTHOR(S) (date) Title of article. Title of journal. [Online] Vol. no. (Part no./Issue/Month).

Some journals such as British Medical Journal (BMJ) and Physical Review Letters use an unusual numbering system where all articles are marked with an article number and all articles begin on page 1. To reference these articles we use the journal article template, with a modified page convention. Author Year, 'Title of journal article', Journal title, Volume number, Issue number, Page range.
