The law relating to industrial action is complicated and many aspects of the law are unclear, either because of conflicting court decisions or because of the absence of judicial interpretation of the key legislation.

Unlike the law in many countries English law does not give workers a positive right to organise or participate in industrial action. A union will be liable if it induces its members

to participate in industrial action without first complying with specific balloting requirements.

The Act introduces a new ballot threshold, requiring a minimum turnout of 50% of those eligible to vote

before a vote for industrial action can be legally binding. In addition to the above requirement, where the vote is in relation to “important public services”, at least 40% of those entitled to vote must vote in favour of industrial action.
